Principles:

- All children have the right to learn and each teacher to teach in a safe, caring and orderly learning environment so that students will reach their full potential.
- We encourage and expect children to behave in an acceptable way at all times.
- The over-riding aim is to develop children who are self-disciplined and behave well because it is the 'right thing' to do rather than out of a fear of being caught doing the 'wrong thing'.
- Each classroom teacher has ownership of the behaviour of their students both in the home classroom, specialist classrooms and during breaks.
- Creating and maintaining a positive, safe learning and p[laying environment is the responsibility of all staff members

Definitions

- O Bullying: when someone says or does something intentionally hurtful and they do it once, that's rude! When someone says or does something intentionally hurtful and they do it once, that's mean! When someone says or does something intentionally hurtful and they keep doing it even when you tell them to stop, or show them that you are upset, that's bullying!
- O There is NO excuse for bullying. It must be dealt with early and effectively.

Common School Rules

Children / students must remain inside the boundary fences and all students must seek permission from the teachers on duty (or the Principal's nominee) before leaving the
school grounds during school hours.
During play times, children must not be in classrooms unless supervised by a teacher and
then only if there is more than one child present.
Play must be safe and so running on verandahs, kicking balls on the area between the
ECE buildings and the north end of the bitumen area are not allowed.
Certain areas are considered to be out of bounds (up trees, and those areas not patrolled
by a duty teacher.)
Chewing gum is not permitted.
No hat, no play.
Students are expected to take care of all personal and public property.

Consequences

To achieve a positive learning environment, teachers will encourage and support appropriate behaviour in the classroom. However, to support this teachers need a consistent set of consequences for inappropriate behaviour. (This is a serious step)

If inappropriate behaviour is demonstrated, we hope students will quickly think and then do the right thing. If it continues a set of consequences based on the following guidelines will apply:

- 1. Reminder Students will be given a reminder about their inappropriate behaviour
- 2. First Time Out Student will be moved to an isolated area within the classroom for 5-10 minutes to reflect on their behaviour. Teachers will negotiate with students about their return. Record in SEQTA (Do not have a 'labelled' spot.

3. Second Time Out - Student moved to the adjacent classroom for up to 30 minutes or the next break ie recess, lunch or home time. Student may or may not have work to do. Teachers negotiate the return of the student at these breaks. Record in SEQTA 4. Third Time Out – The Office. Student spends a negotiated period of time in the Office. Parents will be informed, by the teacher, via phone, that this stage has been reached. Record in SEQTA 5. Fourth Time - Internal Suspension. Internal suspension for 1-2 days in an alternate classroom, with work to do. Spends breaks at Office. Parents informed by phone by the classroom teacher. Record in SEOTA ☐ Behaviour change negotiated ☐ Re-entry plan negotiated ☐ Parents notified and involved in process if they wish. 6. Fifth Time - Suspension (up to five days) ☐ Conference conducted with parents, teacher, Principal, student. ☐ Re-entry plan negotiated ☐ Length of suspension determined □ Documentation must take place and be signed by the Principal and a letter explaining rationale for decision sent or given to the child's parents. Note Well: This policy gives a pathway to suspension. Children are never suspended for minor misdemeanors, no matter how often repeated. If you set a child to complete work or sit out during recess or lunch then you are responsible for supervising that child during that time. **Immediate Suspension** ☐ If a student is unwilling or unable to comply with the above or is a danger to themselves, staff or other children, then suspension will apply immediately. The Principal/Nominee will contact the parents or emergency contact person to organise for an adult to collect the student for the remainder of the day. If there is no adult to collect the child, then internal suspension in the office takes place until parents collect. ☐ When the student returns a re-entry plan and behaviour change plan must be negotiated before returning to class. **Behaviour Code** Our Lady of Grace School is a caring and safe place for students, staff and visitors. NOTE: If a student absconds:

- 1. Inform the Principal / Teacher in Charge
- 2. Make a quick check of the school grounds
- 3. Inform the parent, discuss the incident and student's return to school.
- 4. If parent cannot be contacted, contact the Police who will search and return the student to school.
- 5. A Critical Incident Report must be completed
